4. Update reports:
 - a. Auditor's report on system finances
5. Public Forum: Comments from individuals who signed up to speak, limited to three minutes each
6. Election Results:
 - a. Presiding director reads the Resolution Declaring Unopposed Candidates into the record
7. Closing comments by presiding director.
8. Meeting is adjourned.

Action, if any, will be taken in open session.
